Sanction is hereby accorded to the release of funds to the tune of **Rs.3.00 lacs** (Rupees three lacs only) under SCA to TSP and its placement at the disposal of Superintending Engineer (I&FC) for construction of Khul in Mohalla Chowana near Gagarkote(Seri chowana)under irrigation sector during the current financial year 2016-17.

The authorization is subject to the following conditions:-

1. The funds shall be strictly utilized according to the norms and guidelines prescribed by the Government of India/State Government under the scheme.
2. The funds are utilized after the scheme is technically vetted and administratively approved by the competent authority and the works are executed as per the approved type design.
3. The funds are utilized exclusively for the purpose these are released without creating any liability for future.
4. No diversion of funds in any case is allowed without prior approval of the Competent Authority.
5. That there is no overlapping in funding/covering the area under the scheme from any other scheme of the state/central Government or any of its organisation/Institution.
6. The Monthly Progress report be furnished to Director Tribal Affairs J&K by or before 2nd Day of every month.
7. The utilization Certificate for these funds be furnished to the Director Tribal Affairs J&K well before 31-03-2017.
8. The expenditure is incurred after observing all the codal formalities required under rules/regulations.
