Pursuant to Commissioner/Secretary to Government Disaster Management, Relief, Rehabilitation & Reconstruction Department Communication no. referred above, sanction is hereby accorded to the release of funds to the tune of **Rs. 30.00 lacs (Thirty Lacs)** out of Disaster Response Funds (SDRF) 2017-18 to clear the liability on account of Temporary Restoration of Road from 3rd of TOI to Arai Upper in Poonch District and placed at the disposal of **Executive Engineer PMGSY Poonch** who shall utilized the same after completing all necessary codal formalities.


The authorization is subject to the following conditions:-

1. All the codal formalities required under rule should be completed.
2. That the third party inspection of the work shall be carried out by an officer, not below the rank of Superintendent Engineer, who is not associated with the execution of the work.
3. That there should be no overlapping of funds from any other source.
4. That funds should not be parked unnecessarily.
5. That utilization certificates for the amount shall be furnished immediately.
6. That no further liability shall be created for further.
7. That funds are not re-appropriated without the approval of Competent authority.
