14. That no diversion of funds in any case is allowed without prior approval of competent authority.
15. That there is no overlapping in funding/covering the area under the scheme from any other scheme of the State/Central Government or any of its organization/institution.
16. The Utilization Certificate for these funds is furnished to the Tribal Affairs Department will before the 31.03.2016.
17. That works are community benefit oriented not individual and also serves the interests of ST Community as a whole.
18. That the expenditure is incurred after observing all the codal formalities required under rules/regulations.
