

Pursuant to Planning & Dev. Department Communication no. referred above, the undersigned is directed to convey the authorization for an amount of **Rs. 18.93 lacs (Eighteen Lacs & Ninety Three Thousand Only)** and placed at the disposal of **Executive Engineer PHE Poonch** for execution of works/Schemes as per the details indicated at annexure "A" to this order under normal plan of BADP 2017-18 in border blocks of District Poonch.

The authorization is subject to the following conditions:-

01. All necessary Administrative Approvals and Technical Sanctions shall be obtained prior to the execution of the approved works programme and sanction to the revision in the cost wherever applicable, shall also have to be obtained from the competent authority for incurring expenditure on such projects involving cost revision.
02. The execution of works shall be restricted to the extent of funds released to avoid creation of liabilities.
03. There is no overlapping under the scheme for any other scheme of State/Centre under operation in the same area.
04. Scheme where subsidy element is involved shall not be taken up as per the instruction of the Ministry of Home Affairs, GOI, DoBM.
05. No re-appropriation shall be made from one scheme to another without prior approval of the Planning and Dev. Department.
06. The monthly physical/financial reports shall be submitted to this office invariably by or before 5th of every month on the same format in which the funds have been released.


