Subject: - Compassionate appointment in terms of SRO-43/94. (Militancy related).

Ref:- Hon'ble High Court, J&K Jammu as per order passed Contempt (SWP) No. 56/2014 dated; 17-12-2016.

ORDER

Whereas, one Ghulam Ahmed S/o Mahad Joo R/o Sangla Tehsil Surankote was killed during cross firing between militants and Army on 27-03-2004 and Rs.1.00 lac as admissible has already been paid to the Noks of the deceased.

Whereas, dependent certificate has been issued in favour of Mohd Farooq S/o Ghulam Ahmed R/o Sangla Tehsil Surankote by competent authority vide No. SDM/14 dated; 04-05-2005.

Whereas, an amount of Rs. 4.00 lacs was sanctioned as cash compensation in lieu of Govt. Job under SRO 43/94 in favour of Noks, of deceased person namely Mst. Zalikha Bi Widow, Mohd Farooq, Mohd Rafiq Sons & Mst. Halima Bi D/o Ghulam Ahmed R/o Village Sangla Tehsil Surankote vide this office order No. DCP/ARA/223-28/09 dated 19-02-2009 and was kept as fixed deposited as per Certificate (MYD) bearing No. 3104137 dated; 20-02-2009 but the NOKs of deceased have refused to receive the cash compensation.

Whereas, the applicant Mohd Farooq S/o Ghulam Ahmed approached the Hon'ble High Court as per SWP No. 1909/2010 CMP No. 2670/2010 passed an order dated; 03-09-2012 that "in view of the submission made, the petition is disposed of with a direction to the respondents to accord consideration to petitioner's case on merits and having due regard to the mandate of rules. The Hon'ble High Court, J&K Jammu has passed an order as per Contempt (SWP) No. 56/2014 in SWP No. 1909/2010 to issue appointment order to the petitioner. A Para-wise reply has been submitted before the Hon'ble High Court, J&K Jammu but the Hon'ble High Court, J&K Jammu has passed direction dated 17-12-2016 to issue appointment order to the petitioner.

Whereas, as per direction passed by the Hon'ble High Court, Jammu under Contempt (SWP) No. 56/2014 dated; 17-12-2016, the case has been re-considered to appoint the applicant against available vacant post of Class-IV (orderly) as applicant was eligible both in terms of qualification as well as age.

Whereas, an amount of Rs. 4.00 lacs which was sanctioned as per Fixed Deposit Certificate (MYD) bearing No. 3104137 dated; 20-02-2009 is hereby withdrawn & shall be recovered as arrear.

Therefore, in terms of SRO-43/94 as amended from time to time, sanction is hereby accorded to the appointment of Sh. Mohd Farooq S/o Ghulam Ahmed R/o Sangla Tehsil Surankote Distt. Poonch as Class-IV (Orderly) District Cadre temporarily in the Pay Band 4440-7440+GP 1300 against available vacancy in the office of the Assistant Director, Handloom Development Department, Poonch.

The appointee shall be governed by the SRO-202 of 2015 dated 30th June, 2015 issued under endorsement No.GAD (Adm.) 90/2015-V dated; 30-06-2015 allowed to join only on production of the following certificates in original.

1. Academic qualification certificates.
2. Date of birth certificate.
3. State subject certificate (PRC).
4. Health certificate from the concerned Chief Medical Officer.
5. Certificate from the concerned District Industries Centre (DIC) and District Employment and counselling centre to the effect that no loan under selfemployment scheme has been taken by the appointee.
6. Relevant category certificate (s) issued by the competent authority.

The appointment of the above candidate as Class-IV (orderly) District Cadre shall further be subject to the following conditions:-

- i. The appointee shall submit an affidavit at the time of joining undertaking therein that in case adverse report about his Character and Antecedents is received from the office of the IGP/CID, J&K to whom a reference shall be made by the office of the Deputy Commissioner, Poonch the candidate shall have no right to claim his appointment as orderly.
- ii. Verification/Genuineness of the qualification and reserved category certificate (s) from the concerned and recognition of the institutions from the concerned issuing authorities.
- iii. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of (i) and (ii) above are received in his favour.
- iv. The appointment of the above applicant shall be governed by the New Pension Scheme as per SRO-400 of 2009 dated 24-12-2009.
- v. The appointee shall be report to the concerned office/ Department within 21 days from the date of issuance of this order failing which the provisional appointment shall be deemed cancel.
