For the purpose of issuance of Right of Way / Road cutting permission by the Public Works (R&B) Department for implementation of Business Reform Action Plan (BRAP) under Ease of Doing Business (EoDB), time line as given below has been fixed for various activities, after receipt of formal request from the line department in writing to Chief Engineer PWD(R&B)/its subordinate offices, which be adhered to strictly in letter and spirit by all the functionaries of the department.

1	Forwarding of application by the Executive Engineer to concerned Sub Division	1 day
2	Site visit and taking measurement by Junior Engineer for framing detailed estimate	3 days
3	Endorsement of estimates by AEE to Drawing branch of the Division for check	3 days
4	Submission of framed estimates duly signed by Executive Engineer to Superintending Engineer concerned	2 days
5	Checking of deviation / corrections by the Drawing branch of Superintending Engineer office	2 days
6	Forwarding of case by concerned Superintending Engineer to District Development Commissioner for issuance of NOC	2 days
7	Verification of the documents and issuance of NOC by the District Development Commissioner	7 days
8	Forwarding of copy of estimate alongwith NOC to the Chief Engineer by Superintending Engineer and to the line department for deposition of restoration charges in the office of Chief Engineer	2 days
9	Issuance of necessary direction by the Chief Engineer to the Superintending Engineer for the issuance of NOC to the line department, in case restoration charges are deposited	2 days
