Notice is hereby given that:-


- 1) an election is to be held of **a member to the Jammu and Kashmir Legislative Assembly in the 87-Haveli Assembly Constituency ;**

- 3) nomination paper may be delivered between the hours of 11 in the morning and 3 in the afternoon by a candidate or his authorized agent to any of the officers specified in paragraph 6 at his office on any day not later than the **14th of November, 2014 (Friday);**
- 4) the nomination papers will be taken up for scrutiny at **11.00 A.M on 15th of November, 2014 (Saturday)** at Assistant Commissioner Development's Office(DC office Complex) Poonch;
- 5) notice of withdrawal of candidature may be delivered by a candidate, his authorized agent or election agent to any one of the officers specified in paragraph 6 at his office before **3:00 PM on 17th of November 2014;**
- 6) nomination papers and notices of withdrawal may be delivered to any of the officers specified in column of the following table at his office specified in the corresponding entry in the second column of the table :-
