Subject: **Constitution of Flying Squads (FSs) and Static surveillance teams (SSTs) for conduct of Assembly Elections - 2014 in District Poonch- Monitoring of election expenditure/Model code of conduct-regarding.**

ORDER


Sanction is hereby accorded to the constitution of Flying Squads (FSs) and Static surveillance teams (SSTs) of different compositions (Civil/Police) in each Assembly Constituency of district Poonch as indicated in **Annexure A & B** respectively for monitoring of election expenditure/Model code of conduct (MCC) etc. in conduct of election to 85-Surankote, 86-Mendhar & 87-Haveli Assembly constituencies during the 1st week of December 2014.

The Flying Squads (FSs) will be responsible for tracking illegal cash transactions, distribution of liquor, any other item suspected of being used for bribing the voters whereas the Static surveillance teams (SSTs) will put check posts and keep watch on movement of large quantities of cash, illegal liquor, any suspicious item or arms being carried in their area. The entire process of checking and seizure, if any, shall be videographed.

The Flying Squads (FSs) and Static Surveillance Teams (SSTs)/Check Posts shall follow a Standard Operating Procedure (SOP), issued by Election Commission of India vide Order No.76/Instructions/2013/EEPS/Vol. I Dated: 21st March, 2013 (enclosed as **Annexure A1**) in the Assembly constituencies during election process, and will furnish a Daily Activity Report to RO with copy to DEO, General Observer and Expenditure Observer in the formats enclosed with aforesaid order.

The members of all the flying squads (FSs) and Static surveillance teams (SSTs) shall be under the control of concerned Returning Officer of the Assembly Constituency.

The flying squads (FSs) shall start their work immediately whereas (SSTs) from the date of notification of election and will continue till date of poll/re-poll.
